TO ALL WHOM THESE PRESENTS MAY CONCERN: BRYANT WHITFIELD CANTLEY, JR.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty-nine Thousand Nine Hundred Fifty and 00/100-----DOLLARS

(\$ 39,950.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is Thirty (30) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Paris Mountain Township, and being known and designated as Lot No. 7, containing 1.63 acres, more or less and shown on Plat of property of F. B. Massingale, by J. Coke Smith, Surveyor, dated November 1945, and being more particularly as follows:

BEGINNING at a stake on the West side of a county road, corner of Lot No. 6, property now owned by Irene D. Thames; thence with line of her lot, N. 67-15 W. 455 feet to a stake on Saluda River; thence down and with said river 193 feet, more or less, to stake in line of Lot No. 8; thence with line of Lot No. 8, now or formerly owned by Rowland and Johnson, S. 76-18 E. 417 feet to a stake on said road; thence with said road, N. 19-45 E. 129.7 feet, more or less to the BEGINNING.
