(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Fifteen Thousand and 00/100 (\$15,000.00)----- DOLLARS

(\$ 15,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Austin Township, being known and designated as Lot 11 on a Plat of property of J. W. Whitt, made by C. O. Riddle, Surveyor, February 22, 1956, and recorded in Plat Book PP, Page 99, R.M.C. Office for Greenville County and also shown on a more recent Plat of said property of Verbon C. and Alice K. Peppers, prepared by R. B. Bruce, Surveyor, and being more particularly described, according to Plat of J. W. Whitt property, to-wit:
