(hereinafter referred to as Mortgagor) SEND(S) GREETING

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty Three Thousand Five Hundred----- DOLLARS

(\$ 23,500.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 29 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lots 19 and 20, as shown on a plat of Pleasantdale, Prepared March, 1957, which plat is of record in the Office of the R.M.C. for Greenville County in Plat Book QQ, at Page 19, and having, according to said plat the following metes and bounds, to wit:

Lot 20: BEGINNING at an iron pin on the Northern side of Pleasantdale Circle, at the joint corner of Lots 26 and 20; thence along the Northern side of said Pleasantdale Circle, N. 89-25 W. 45.9 feet; thence S. 88-45 W. 54 feet to an iron pin; thence along the common line of Lots 19 and 20, N. 0-06 W. 300 feet to an iron pin; thence N. 84-45 E. 101.2 feet to an iron pin; thence S. 0-06 E. 315 feet to an iron pin, being the beginning corner.

Lot 19: BEGINNING at an iron pin on the Northern side of Pleasantdale Circle at the joint corner of Lots 19 and 20; thence along the Northern side of Pleasantdale Circle, N. 73-45 W. 33 feet; thence N. 67-06 W. 56 feet; thence N. 68-47 W. 18 feet to an iron pin, joint front corners of Lots 18 and 19; thence along the common line N. 0-06 W. 253.5 feet to an iron pin; thence N. 84-45 E. 100.4 feet to an iron pin, joint rear corners of Lots 19 and 20; thence along the common line of Lot 20, S. 0-06 E. 300 feet to an iron pin, being the beginning corner.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagor promises to pay to the mortgagee for the term of the guaranty policy the sum of 1/48th of 1% of the original amount
