(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty-Two Thousand and no/100 -----DOLLARS

(\$ 32,000.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Greenwood Avenue near the city of Greenville being shown and designated as Lot No. 51 on plat of Hudson Acres prepared by Woodward Eng. and Construction Co. & T. C. Hill Associates dated June, 1950, said plat being recorded in the R. M. C. Office for Greenville County in Plat Book Y at Page 39 and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Greenwood Avenue at the joint corner of Lot Nos. 51 and 52 and running thence along and with the joint property line of said two lots, S. 29-50 W. 146 feet to an iron pin; thence S. 58-00 E. 148.9 feet to an iron pin at the joint corner of Lot Nos. 50 and 51; thence running along and with the northern side of Greenwood Avenue, N. 51-00 E. 175 feet to an iron pin; thence continuing along the curve of Greenwood Avenue, the chord of which is N. 24-45 W. 23 feet and N. 30-30 W. 25 feet to an iron pin; thence running along and with the northern side of Greenwood Avenue N. 75-15 W. 195 feet to the beginning.
