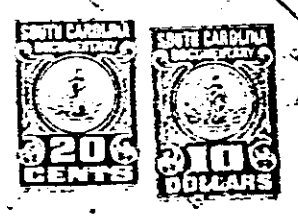

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on Parliment Road, being shown and designated as Lot No. 26, on plat of Section II, Merrifield Park, recorded in the RMC Office for Greenville County, S. C., in Plat Book "WWW", at Pages 50 and 51, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southerly side of Parliment Road, joint front corner of Lots Nos. 25 and 26, and running thence with the joint lines of said lots, S. 14-02 W. 167.3 feet to an iron pin; thence N. 74-58 W. 115 feet to an iron pin, joint rear corner of Lots Nos. 26 and 27; thence with the joint lines of said lots, N. 14-03 E. 165.6 feet to an iron pin on the southerly side of Parliment Road; thence with the southerly side of Parliment Road, S. 75-55 E. 115 feet to an iron pin, the point of BEGINNING.
