TO ALL WHOM THESE PRESENTS MAY CONCERN: George F. Durovchic and
Frances M. MacDonald (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Forty-one Thousand Three Hundred and No/100-----DOLLARS

(\$ 41, 300. 00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is thirty (30) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Mauldin, being known and designated as Lot No. 7 of a subdivision known as Glendale III, a plat of which is recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4-R, at pages 83 and 84, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on Fargo Street, joint front corner of Lots 7 and 8, S. 49-50 W. 100 feet to a point, joint front corner of Lots 6 and 7; thence with the common line of Lots 6 and 7, N. 40-10 W. 258.8 feet to a point, joint rear corner of said lots; thence turning and running N. 46-43 E. 100.15 feet to a point, joint rear corner of Lots 7 and 8; thence turning and running with the common line of Lots 7 and 8, S. 40-10 E. 264.2 feet to the point of beginning.

This property is the same conveyed to the Grantors herein by deed of Hoy Z. O'Shields d/b/a Hoy Z. O'Shields Builders by deed of even date, to be recorded herewith.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagor promises to pay to the mortgagee for the term of the guaranty policy the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance
