WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Eight thousand and no/100-----DOLLARS

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the northeastern intersection of Montana Avenue and Dyer Streets, and being known and designated as a portion of Lot 89 on plat of Morgan Hill and shown in Plat Book A at Page 170 and being more particularly shown on plat of the property of Ruth S. Oates, prepared by Carolina Surveying Company, dated July 13, 1973 and having the following metes and bounds, to-wit:
