WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty-one Thousand Five Hundred and no/100ths ----- DOLLARS

(\$ 31,500.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon situate, lying and being in the State of South Carolina, County of Greenville, on the northwest corner of the intersection of Rockmont Road and Wendover Road, being known and designated as Lot No. 174 on a plat of LAKE FOREST, SECTION III, made by Piedmont Engineering Service, dated August, 1954, recorded in the RMC Office for Greenville County, S. C., in Plat Book GG at page 77, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Rockmont Road at the joint front corner of Lots Nos. 173 and 174, and running thence with common line of said lots, S. 65-52 W., 171.4 feet to an iron pin; thence along the common line of Lots Nos. 174 and 175, S. 17-35 E., 125 feet to an iron pin on the northwestern side of Wendover Drive; thence along the northwestern side of Wendover Drive, N. 77-58 E., 80 feet to an iron pin; thence continuing along said drive, N. 81-49 E., 61.6 feet to an iron pin; thence with the curve of the intersection of Wendover Drive and Rockmont Road, the chord of which is N. 33-00 W., 32.9 feet to an iron pin on the western side of Rockmont Road; thence with the western side of Rockmont Road, N. 15-49 W., 141.2 feet to an iron pin, the point of beginning.
