TO ALL WHOM THESE PRESENTS MAY CONCERN: Claude E. Draper and Martha L. Draper

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Seventeen Thousand and Five Hundred Fifty and No/100----- DOLLARS

(\$ 17,550.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Longview Terrace in the City of Greenville, being known and designated as Lot 44 of Forest Heights Subdivision, plat of which is recorded in the RMC Office for Greenville County in Plat Book P at Page 71 and having, according to said plat, the following metes and bounds, to - wit:

Beginning at a point on the northern side of Longview Terrace, at the joint front corner of Lots 43 A and 44 and running thence along the common line of said Lots N.45-22 E. 118.7 feet to a point at the joint rear corner of said Lots; thence N.47-46 W. 125 feet to a point; thence to a point at the joint rear corner of Lots 44 and 45; thence continuing along the common line of said Lots S.2-44 W. 147.3 feet to a point at the joint front corner of said lot on Longview Terrace; thence continuing along Longview Terrace S.59-25 E. 76 feet to the point of beginning.

The mortgagors agree that after the expiration of ten years from the date hereof, the mortgagee may at its option apply for mortgage insurance for an additional period of five years with the mortgage insurance company insuring this loan, and the mortgagor agrees to pay to the mortgagee as premium for such insurance one half of 1% of the principal balance then existing.
