ANSELL B. PARKER & BILLIE J. PARKER,

(hereinafter referred to as Mortgagor) SEND(S) GREETINGS

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

--TWENTY TWO THOUSAND AND NO/100

DOLEARS

(\$ 22,000.00----), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is ---25--- years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot 8, on plat entitled "Deerwood", and recorded in the RMC Office for Greenville County in Plat Book 4-J, at Page 167, and being prepared by Campbell & Clarkson, Surveyors, Inc., dated March 27, 1972, and being more particularly described in accordance with said plat, to-wit:

BEGINNING at a point on the edge of Deerwood Circle, said point being the joint front corner with Lot 9, and running thence along the joint property line of Lot 9, S. 77-00 W. 270 feet to a point, said point being the joint rear corner with Lot 9; thence along the joint property line of Lot 4, N. 5-00 W. 110 feet to a point, said point being the joint rear corner of Lots 4 and 5; running thence along the joint line of Lot 5 N. 11-19 E. 70 feet to a point, said point being the joint rear corner of Lots 5 and 6; thence continuing along the same call (N. 11-19 E.) along the joint property line of Lot 6, 62.9 feet to a point, said point being the joint corner with Lots 6, 7 and 8; thence along joint property line of Lot 7, N. 77-00 E. 200 feet to a point in the edge of Deerwood Circle, said point being the joint front corner of Lots 7 and 8, thence along the edge of Deerwood Circle S. 13-00 E. 230 feet to the point of beginning.
