Whereas, the Mortgagee, at its option, may hereafter make additional advances to the Mortgagor, or his successor in title, at any time before the cancellation of this mortgage, which additional advance(s) shall be evidenced by the Note(s) or Additional Advance Agreement(s) of the Mortgagor, shall bear such maturity date and other provisions as may be mutually agreeable, which additional advances, plus interest thereon, attorneys' fees and Court costs shall stand secured by this mortgage, the same as the original indebtedness, provided, however, that the total amount of existing indebtedness and future advances outstanding at any one time may not exceed the maximum principal amount of

Ten Thousand Three Hundred Twenty Five & No/100*** Dollars (\$ 10,325.00), plus interest thereon, attorneys' fees and Court costs.

Now, Know All Men, the Mortgagor in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of One Dollar (\$1.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns the following-described property:

ALL that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville and being shown and designated as Lot No. 8 on a plat of property of J.B. Bruce and Dr. A. White recorded in the RMC Office for Greenville County in Plat Book E at page 58 and according to said plat, having the following metes and bounds, to-wit:

BEGINNING at a stake, corner of Lot 7 and running thence N13W, 48 feet, 4 inches to a stake at the corner of Lot 9; thence with the line of Lot 9, S73W, 141 feet to an unnamed street; thence with said unnamed street, S13E, 48 feet and 4 inches to the corner of Lot 7; thence with the line of Lot 7, N73 1/2E, 141 feet to the beginning corner.
