All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the County of Greenville and being known and designated as Lot 6, Windtree Subdivision, according to a plat prepared of said property by C. O. Riddle, Surveyor, July 1, 1977, and which said plat is recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 6-H, at Page 12, and according to said plat having the following courses and distances, to-wit:

BEGINNING at a point on the edge of Windtree Court, joint front corner with Lot 7 and running thence with the common line with Lot 7, N. 71-24 W. 335.6 feet to a point; thence, S. 18-37 W. 128.9 feet to a point in the line with Lot 5; thence running with the common line with Lot 5, S. 66-00 E. 327.8 feet to a point on the edge of Windtree Court; thence running with the edge of said court, N. 23-20 E. 112.7 feet to a point on the edge of said court; thence continuing with the edge of said court, N. 18-36 E. 47.3 feet to a point on the edge of said court, the point of beginning.
