WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty Three Thousand Two Hundred and 00/100----- DOLLARS

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on Old Mill Court, being shown and designated as Lot No. 22, on plat of Old Mill Estates, Section 1, recorded in the RMC Office for Greenville County, S. C., in Plat Book "000", at Page 159, and having the following metes and bounds, to wit:
