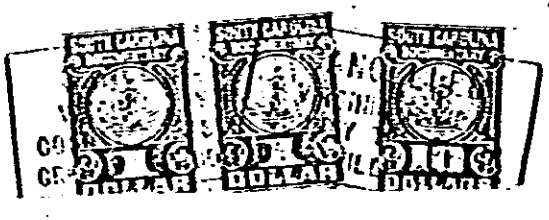

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Butler Springs Road being shown and designated as Lot No. 26 on a plat of Heritage Hills by Piedmont Engineers & Architects dated May 26, 1964 recorded in the RMC Office for Greenville County, South Carolina in Plat Book YY, page 187 and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Butler Springs Road at the joint front corner of Lots Nos. 26 and 27 and running thence with the common line of said lots, N. 9-45 W. 170 feet to an iron pin in a Duke Power right of way; thence N. 80-15 E. 105 feet to an iron pin at the joint rear corner of Lots Nos. 26 and 25; thence with the common line of said lots, S. 9-45 E. 170 feet to an iron pin on the northern side of Butler Springs Road; thence with the northern side of Burtler Springs Road, S. 80-15 W. 105 feet to an iron pin, the point of beginning.
