THIS MORTGAGE is made this 10th day of May 1979, between the Mortgagor, Terry Lee Ayers (herein "Borrower"), and the Mortgagee, UNITED FEDERAL SAVINGS AND LOAN ASSOCIATION OF FOUNTAIN INN, a corporation organized and existing under the laws of the United States of America, whose address is 201 Trade Street, Fountain Inn, S. C. 29644 (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Thirty Five Thousand and no/100ths Dollars, which indebtedness is evidenced by Borrower's note dated May 10, 1979 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on October 1, 2009;

O. Riddle, Surveyor, dated August 31, 1976 as amended and revised on March 1, 1979 and recorded in Plat Book 7-B at page 31 and having such metes and bounds as appear by reference to said plat. The subject property fronts on the southerly side of Harness Trail a total distance of 150 feet.
