WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

Fifteen Thousand and No/100----- DOLLARS

(\$ 15,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 20 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

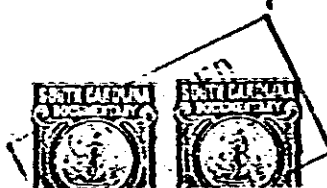

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

ALL that piece, parcel or lot of land situate lying and being on the Eastern side of Derewood Lane near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as Lot No. 41, of a subdivision of an Extension of Sharon Park, plat of which is recorded in the R.H.C. Office for Greenville County in Plat Book CCC at Page 71 and according to said plat has the following, metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Derewood Lane at the joint front corner of Lots Nos. 41 and 42; and running thence with the joint line of said lots S. 72-50 E. 150 feet to an iron pin; running thence S. 38-05 W. 107 feet to an iron pin at the joint rear corner of Lots Nos. 41 and 61; running thence with the joint line of said lots N. 60-15 W. 135.1 feet to an iron pin on the Eastern side of Derewood Lane; running thence with Eastern side of said Lane N. 33-30 E. 75 feet to an iron pin point of beginning.
