WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of **Fifteen Thousand and no/100-----** DOLLARS (\$ 15,000.00-- ), with interest thereon at the rate of **5-3/4%** per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is **15** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of Saluda Dam Road, in Greenville Township, being shown as a major portion of tract 5 on plat of the property of R. A. Means, recorded in Plat Book H at page 144 and also being shown as tract 3.1, block 2, page B-14 of the County Block Book and more particularly described as follows:

BEGINNING at a stake on the Southern side of White Horse Road, corner of property now or formerly owned by Alice M. Moore and running thence S. 35 1/2 W. 706.8 feet to a pin; thence S. 48-3/4 E. 435.6 feet to a pin; thence S. 49-3/4 E. 84.4 feet to a pin; thence N. 35-3/4 E. 411 feet to a pin; thence N. 72-40 W. 4 feet to a pin; thence N. 26-45 E. 439.6 feet to a pin on Saluda Dam Road; thence with the Southern side of said road, N. 70 W. 411.9 feet to the point of Beginning.
