TO ALL WHOM THESE PRESENTS MAY CONCERN:

R. & T. REALTY CO., INC., a South Carolina Corporation
(hereinafter referred to as Mortgagor) SENDS GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Sixty Thousand and no/100 DOLLARS (\$ 60,000.00), with interest thereon at the rate of six and one-half per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is twelve (12) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the westerly side of Camp Road, also known as Rutherford Road, just outside the corporate limits of the City of Greenville, and having according to a plat made by C. O. Riddle, dated May 30, 1966, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Camp Road, joint corner with Shriners Hospital, and running thence along the westerly side of Camp Road N 24-28 E 300 feet to an iron pin, corner of property now or formerly of B. Frank Thackston, Eugene Bryant and Andrew B. Marion, and running thence along the line of Thackston, et al., N 51-40 W 251.5 feet to an iron pin; thence N 24-28 E 176.5 feet to an iron pin; thence N 51-40 W 170.1 feet to an iron pin in the right-of-way of Southern Railroad; thence along said Railroad right-of-way S 47-57 W 469.3 feet to an iron pin, corner of property of Shriners Hospital; thence along said Hospital line S 51-40 E 613.7 feet to an iron pin, the point of beginning.
