(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

Eighty Five Thousand ----- DOLLARS

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, located in the Berea section, being a portion of the property of N. A. Howard, located on the Northern side of the Cedar Lane Road and having the following metes and bounds, to wit:

Beginning at an iron pin in the center of Cedar Lane Road, at a point 2 feet West of Lot No. 5 as shown on plat recorded in plat book "Q" page 87, Greenville County R. M. C.
