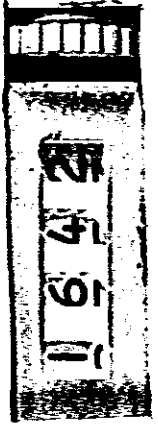
All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being a portion of Section B, shown on plat of Stone Land Company recorded in Plat Book A at pages 357-358 in the RMC Office for Greenville County, and having the following metes and bounds:

Beginning at an iron pin on the northern side of Townes Street, corner of alley; thence with the alley, N 83-13 W 104.4 feet; thence S 1-41 W 100 feet; thence S 83-13 E 104.4 feet to an iron pin on Townes Street; thence with Townes Street, N 1-41 E 100 feet to the point of beginning.
