In consideration of such loans and indebtedness as shall be made by or become due to THE BANK OF GREER, GREER, S. C. (hereinafter referred to as "Bank") to or from the undersigned, jointly or severally, and until all of such loans and indebtedness have been paid in full, or until twenty years following the death of the last survivor of the undersigned, whichever first occurs, the undersigned, jointly and severally, promise and agree

- 1. To pay, prior to becoming delinquent, all taxes, assessments, dues and charges of every kind imposed or levied upon the real property described below; and
- 2. Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; or any leases, rents or funds held under escrow agreement relating to said premises; and

3. The property referred to by this agreement is described as follows: All that lot of land with buildings and improvements thereon, situate at the Northeastern corner of the intersection of Bridge Road and Melvin Circle, in Greenville County, State of South Carolina, near Taylors, being shown and designated as Lot No. 13, on a Plat of Chick Springs Subdivision, Section 2, dated July 18, 1966, made by Piedmont Engineers & Architects, and recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book PPP, Page 75, and having, according to said Plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the Eastern side of Bridge Road at the joint front corners of Lots Nos. 13 and 14, Section 2, and running thence along the common

That if default be made in the performance of any of the terms hereof, or if default be made in any payment of principal or interest (cont on back) or hereafter signed by the undersigned, the undersigned agrees and does hereby assign the rents and profits arising or to arise from said premises to the Bank and agrees that any judge or jurisdiction may, at chambers or otherwise, appoint a receiver of the described premises with full authority to take possession thereof and collect the rents and profits and hold the same subject to the further order of said court.

4. That if default be made in the performance of any of the terms hereof, or if any of said rents or profits be not paid to Bank when due, Bank at its election, may declare the entire remaining unpaid principal and interest of any indebtedness then existing to Bank to be due and payable forthwith.

5. That the Bank may and is hereby authorized and permitted to cause this instrument to be recorded, at such time and in such place as Bank, in its discretion, may elect.

6. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be null and void and of no effect, and when it shall apply to and bind the undersigned, their heirs, legattes, devisees, administrators executors and assigns, any figure or signature of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing that the sum of \$1000.00 has been paid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement. The undersigned may and is hereby authorized to rely thereon.
