REAL PROPERTY AGREEMENT

1. To pay, prior to becoming delinquent, all taxes, assessments, dues and charges of every kind imposed or levied upon the real property described below; and

2. Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; or any leases, rents or funds held under escrow agreement relating to said premises; and

3. The property referred to by this agreement is described as follows: **ALL that piece, parcel or lot of land situated, lying and being in the State of S. C., County of Greenville, known and designated as Lot No. 30, as shown on plat of Greenfields, recorded in plat book XX page, 103 and having according to said plat the following metes and bounds, to-wit: BEGINNING at an iron pin on the north side of Greenfield Dr., the joint front corner of Lots 31 and 30, and running thence with the joint line of said lots N. 21-59 E, 175 feet to an iron pin; thence N. 68-01 W. 165 ft. to an iron pin joint rear corner of Lots 29 and 30; thence with the joint line of said lots S. 3-19 W. 184 ft. to an iron pin on the north side of Greenfield Dr.; thence with the north side of said street S. 68-01 E. 107.1 ft. to the beginning corner. This is one of the lots conveyed to the grantors by deed of Wade Hampton Septice Tank Service, Inc. recorded May 30, 1972 in deed book 945 at page 87 in the REC-Office for Greenville County,**

That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and payable forthwith.

4. That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and payable forthwith.

5. That the Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.

6. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legacies, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.

S. C. and is conveyed subject to any restrictions, reservations, zoning ordinances or easements that may appear of record, on the recorded plat or on the premises.
