(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Forty-seven Thousand Nine Hundred Fifty and No/100----- DOLLARS

(\$ 47,950.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is thirty years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwesterly side of Sugar Creek Lane near the City of Greenville, South Carolina, being known and designated as Lot No. 135 on a plat entitled "Map 4, Section One, Sugar Creek" as recorded in the RMC Office for Greenville County, South Carolina in Plat Book 5D, at page 72, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly side of Sugar Creek Lane, said pin being the joint front corner of Lots No. 134 and 135 and running thence with the southwesterly side of Sugar Creek Lane S 30-44-00 E 86.76 feet to an iron pin; thence continuing with said Lane on a curve the chord of which is S 15-12-00 E 102.23 feet to an iron pin; thence continuing with said Lane S 00-20-00 W 126.7 feet to an iron pin in the line of property now or formerly owned by Collett & Coleman; thence N 36-51-00 W 36.60 feet to an iron pin; thence continuing N 36-18-12 W 259 feet to an iron pin, the joint rear corner of Lots No. 134 and 135; thence with the common line of said lots N 59-16-00 E 126.45 feet to an iron pin, the point of beginning.
