TO ALL WHOM THESE PRESENTS MAY CONCERN:

MARY ANN W. SNYDER

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of ~~Thirteen~~ Thousand Five Hundred and no/100

(\$13,500.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is fifteen (15) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot No. 4 on plat of property of Nell T. Ward, dated July 16, 1947 and being also described on a more recent survey by T. C. Adams, dated March 27, 1960, as follows:

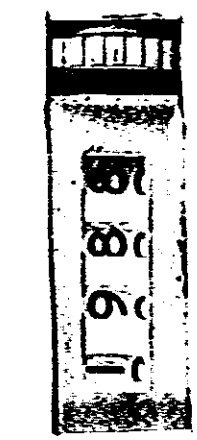
BEGINNING at an iron pin at the northeastern corner of property now or formerly belonging to Nell T. Ward at a point 370 feet east of New Buncombe Road and running thence N. 83-28 E. 167.4 feet to an iron pin; thence S. 34-00 E. 215 feet to an iron pin; thence S. 75-07 W. 26.1 feet to an iron pin at the joint corners of Lots No. 3 and 4; thence with the line of Lot No. 3 N. 6-32 W. 145.5 feet to a point at the rear of a 19 foot street sometimes referred to as Forest Drive; thence across the end of said street N. 6-32 W. 20 feet to an iron pin, the point of beginning.
