WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-four thousand, one hundred eighty-one and 51/100 DOLLARS

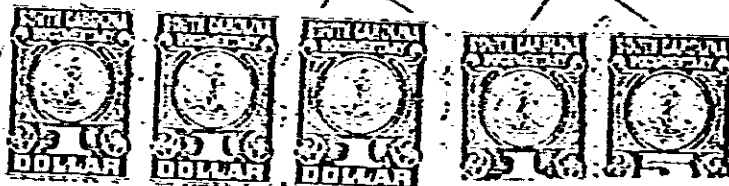
(\$ 24,181.51), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 23 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Covington Road, being shown and designated as Lot No. 100 on a plat of NORTHWOOD HILLS, SECTION III, made by Piedmont Engineering Service dated November 1960 and recorded in the RMC Office for Greenville County, S.C. in Plat Book YY, page 37 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Covington Road at the joint front corners of Lots Nos. 99 and 100 and running thence with the western side of a curve of Covington Road, the chord of which is S 14-55 W 55.9 feet to a point; thence continuing with the curve on the north-western side of Covington Road, the chord of which is S 70-32 W 110 feet to an iron pin at the corner of Lot No. 101; thence with the line of said lot N 59-56 W 206.5 feet to a point; thence N 31-36 E 135 feet to an iron pin at the joint rear corners of Lots Nos. 99 and 100; thence along the common line of said lots, S 61-04 E 260 feet to the point of BEGINNING.
