THIS MORTGAGE is made this 13th day of October, 1978, between the Mortgagor, Burbette A. Moorer

, (herein "Borrower"), and the Mortgagee, South Carolina Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 1500 Hampton Street, Columbia, South Carolina (herein "Lender").

BEGINNING at a point on the western side of Lee East Court, joint front corner of Lots 5 and 6, and running thence with the common line of said Lots, N 89-21 W, 143.4 feet to a point; thence with the rear line of Lot 6, N 2-02 E, 72 feet to a point, joint rear corner of Lots 6 and 7; thence with the common line of said Lots, S 88-35 E, 142.5 feet to a point on the western side of Lee East Court; thence with said Lee East Court, S 1-28 W, 70 feet to the point of beginning.
