

All that certain piece, parcel, or lot of land, with all improvements thereon, or bereafter to be constructed thereon, situate, bing and being in the State of South Carolina, County of Greenville and lying and being on the Corner of Connecticut Drive and Parliment Road and being shown as Lot No. 45 on a plat of Merrifield Park, Section II, recorded in the RMC Office for Greenville County in Plat Book WWW at Pages 50 and 51 and having, according to said plat, the following metes and bounds, to-wit:
