Joseph D. Waller and Louise A. Waller
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

Eight Thousand Five Hundred and no/100--- DOLLARS

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being on the South side of West Earle Street and consisting of the Eastern portion of Lot 10 and the Western portion of Lot 11 of Section D as shown on a plat of the property of the Stone Land Company, said plat made by J. E. Surrine, May 21, 1909 and recorded in the RMC Office for Greenville County in Plat Book A at pages 337-342, said lot of land having a frontage on West Earle Street of 60 feet and a depth of 200 feet.
