Malcolm L. Blackmon

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 65 on plat of Berea Heights Subdivision, Section IV, recorded in Plat Book QQQ at page 23, RMC Office for Greenville County, and having according to said plat the following metes and bounds:

Beginning at an iron pin on the northeastern side of Hardwick Drive at the joint front corner of Lots 64 and 65 and thence with the northeastern side of Hardwick Drive, N 39-10 W 90 feet to an iron pin at corner of Berea Heights Road; thence with the curve of said corner, N 6-26 E 28.1 feet to an iron pin on the southeastern side of Berea Heights Road; thence with the southeastern side of Berea Heights Road, N 52-03 E 162 feet to an iron pin; thence S 39-10 E 106.4 feet to an iron pin at rear corner of Lot 64; thence with line of said lot, S 50-50 W 182 feet to the beginning corner.
