NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 10, Block A, as shown on plat entitled, "Property of Melvin Land Company, Subdivision Number 2," dated May 1905, prepared by Lockwood Green & Company, and having, according to a more recent plat prepared by R. W. Dalton, R. S., the following meets and bounds:

Beginning at an iron pin on the Southeastern side of Sumner Street at the joint front corner of Lots Nos. 9 & 10 and running thence with the line of Lot No. 9 S.74-01 E. 192.1 feet to an iron pin on the Northwestern side of Fincher Street (formerly a 20 foot alley) at the joint rear corner of Lots Nos. 9 & 10; thence with the Northwestern side of Fincher Street S.16-54 W. 51.17 feet to an iron pin on Fincher Street at the joint rear corner of Lots Nos. 10 & 11; thence with the line of Lot No. 11 N.74-23 W. 191.6 feet to an iron pin on the Southeastern side of Sumner Street; thence with the Southeastern side of Sumner Street N.16-20 E. 52.3 feet to the point of beginning.
