TO ALL WHOM THESE PRESENTS MAY CONCERN: James W. Looper

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of ----- Six Thousand Three Hundred and no/100----- DOLLARS (\$6,300.00-----), with interest thereon at the rate of six (6%)----- per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is fifteen years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, on the western side of a county road leading off Farr's Bridge Road, and being a portion of tracts 7 and 8, as shown on plat recorded in Plat Book G at pages 54 and 55, and having the following metes and bounds, according to plat and survey made by W. A. Hester, April 3, 1941, to-wit:

BEGINNING at an iron pin on the northwest side of the county road first above referred to and running thence with said road, N. 26-35 E. 125 feet to bend; thence continuing with said road, N. 43 E. 205 feet to iron pin corner of property now or formerly owned by Stella B. Looper; thence with the line of the property of Stella B. Looper, N. 58 W. 443.5 feet to iron pin; thence S. 19 E. 532 feet to point of beginning.
