

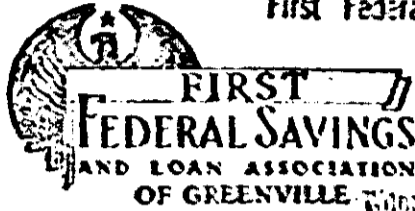

MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

CHRIS O. TURNER

(Hereinafter referred to as Mortgage) (SENATOR'S OFFICE)

WHEREAS, the Mortgage is well and truly indited into FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and true sum of

--- Sixteen Thousand and No/100 --- (\$ 15,000.00)

Dollars as evidenced by Mortgagee's promissory note of even date hereunto, which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain conditions), said note to be repaid with interest at the rate or rates therein specified in installments of

--- One Hundred, Forty-One and 40/100 --- \$ 141.40) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balance, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 20 years after date, and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any law or the Charter of the Mortgagee, or any regulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collateral given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings, and

WHEREAS, the Mortgagee may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagee's account for the payment of taxes, insurance premiums, repairs, or for any other purpose.

NOW, KNOW ALL MEN, That the Mortgagee, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagee's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagee as found well and truly paid to the Mortgagee at and before the reading of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lot No. 34 of a subdivision known as Rosedale as shown on plat thereof prepared by C. O. Riddle, R.L.S., February, 1959, revised May and June, 1960, and recorded in the R. M. C. Office for Greenville County in Plat Book QQ, at Pages 112 and 113, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Rosemary Lane at the point where the northern side of Rosemary Lane intersects a turnaround at the end of s d street, and running thence along the northern side of Rosemary Lane, N. 73-52 W. 84.4 feet to an iron pin; thence following the curvature of Rosemary Lane as it intersects with Tulane Circle, the chord of which is N. 28-52 W. 35.4 feet to an iron pin on the eastern side of Tulane Circle; thence along the eastern side of Tulane Circle, N. 16-00 W. 125 feet to an iron pin; thence S. 73-50 W.
