David C. Foyg and Pamela T. Foyg (hereinafter referred to as Mortgagor) SEND(S) GREETING

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C. (hereinafter referred to as Mortgagee) in the sum of Forty-six Thousand and No/100 _____ DOLLARS

(\$46,000.00), as evidenced by the Mortgagee's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is _____ 30 _____ years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagee may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security;

NOW, KNOW ALL MEN, That the Mortgagee, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagor, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

ALL that certain piece, parcel or lot of land, with improvements thereon, situate, lying and being on the southeastern side of Sun Meadow Road near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as Lot No. 122 of a subdivision known as Sugar Creek, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book 6-B at Page 2 and according to said plat has the following notes and bounds, to-wit:

BEGINNING at a point on the southeastern side of Sun Meadow Road at the joint front corner of Lots Nos. 121 and 122 and running thence with the joint line of said lots S. 50-52-22 E., 172.91 feet to a point; thence N. 38-36-18 E., 125 feet to a point at the joint rear corner of Lots Nos. 122 and 123; running thence with the joint line of said lots N. 50-52-22 W., 171.77 feet to a point on Sun Meadow Road; running thence along the southeastern side of said road, S. 39-07-38 W., 124.99 feet to the point and place of beginning.
