TO ALL WHOM THESE PRESENTS MAY CONCERN

HENRY H. RUND and HELEN P. RUND (hereinafter referred to as Mortgagor) SEND(S) GREETING

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagee in hand well and truly paid by the Mortgagor at and before the reading and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, situate on the Eastern side of Mont Verde Avenue and having, according to Plat made by C. O. Riddle in July, 1960, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Mont Verde Avenue, the joint front corner of property owned by D. A. Hauk, and running thence S. 66-06 E. 624.4 feet to pin on branch; thence with branch as a line, N. 26-46 E. 102.8 feet to pin; thence continuing with branch, N. 40-02 E. 69 feet to pin; thence still continuing with branch, N. 58-49 E. 31 feet to pin; thence N. 61-55 W. 667.3 feet to a pin on Mont Verde Avenue; thence with the Eastern side of said Avenue the following: S. 30-06 W. 60.1 feet to pin; S. 28-35 W. 79.3 feet to pin; thence S. 21-04 W. 39.9 feet to point of BEGINNING.
