All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the southwestern side of Lanneau Drive, and being known and designated as Lot No. 18 on Plat of Property of JOHN T. JENKINSON ESTATE, prepared by Dalton & Neves dated July 1932, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book "H", at Pages 207 and 208, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Lanneau Drive at the joint front corner of Lots Nos. 13 and 19 and running thence with the common line of said Lots S. 39-30 W., 152.8 feet to an iron pin; thence N. 67-35 W., 55 feet to an iron pin at the joint rear corner of Lots Nos. 17 and 18; thence with the common line of said Lots N. 35-25 E., 165.2 feet to an iron pin on the southwestern side of Lanneau Drive; thence with said Drive S. 54-16 E., 65 feet to the point of beginning.
