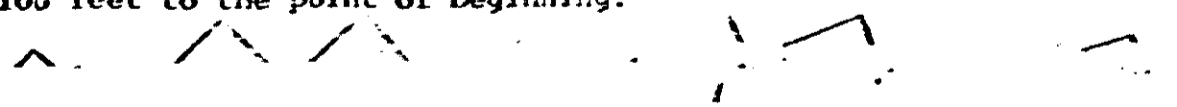

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the South side of Cromwell Avenue, being shown as a portion of Lots 16, 17, 18 and 19 in plat of property entitled "Property of Hicks & Jackson", recorded in Plat Book E at Page 258 in the 339C Office for Greenville County and being more recently shown on survey by C.C. Jones dated June 18, 1960, as follows:

BEGINNING at an iron pin on the Southwest side of Cromwell Avenue, said iron pin being, S 44-20 E 137 feet from the intersection of Cromwell Avenue and Lupo Street, at the joint front corner of Lots 19 & 20; thence with the line of Lot 20, S 43-19 W 120 feet to an iron pin on the Northeastern side of Cherry Avenue; thence with said Avenue, S 46-41 E 100 feet to an iron pin at the joint front corner of Lots 15 & 16; thence with the line of Lot 15, N 43-19 E 119 feet to an iron pin on Cromwell Avenue; thence with the Southwest side of said Avenue, N 44-20 W 100 feet to the point of beginning.
