Charles D. Long

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eight Thousand and No/100

DOLLARS (\$ 8000.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

lying on the northeast side of Peachtree Lane, in or near the Town of Mauldin, shown as lot # 39 on a plat of Peachtree Terrace, recorded in Plat Book EE at Page 189, and according to said plat being more particularly described as follows;

BEGINNING at an iron pin on the northern side of Peachtree Lane, front corner of lot # 38, and which pin is 255.8 feet southeast of the intersection of said lane with Crestwood Drive; thence with the line of lot # 38, N. 41 E. 175 feet to iron pin; thence S. 49 E. 95 feet to iron pin, rear corner of lot # 40; thence with the line of lot # 40, S. 41 W. 175 feet to iron pin on the northeast side of Peachtree Lane; thence with the northeast side of said Lane, N. 49 W. 95 feet to the point of beginning.
