TO ALL WHOM THESE PRESENTS MAY CONCERN:

VAN D. WEAVER AND DOROTHY H. WEAVER

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C. (hereinafter referred to as Mortgagee) in the sum of-----  
Thirty-Seven Thousand Five Hundred and No/100-----DOLLARS

(\$ 37,500.00-----), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty-five years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagee in hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as a portion of Lots Nos. 34, 35 and 36 on a plat entitled PARK HILL made by R. F. Dalton, dated November 1936, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book 1, pages 36 and 37, and being shown on a more recent plat entitled Property of N. J. Helms and Anne P. Helms made by Piedmont Engineering Service dated August 1, 1951, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book AA page 102, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Aberdeen Drive at the intersection thereof with Sevier Street Extension East which iron pin is situate on the eastern side of a 5 foot screen as shown on said plat, and running thence along the northern side of Aberdeen Drive, S. 65-55 E., 80 feet to an iron pin; thence through Lots Nos. 34, 35 and 36, N. 28-50 E., 185.4 feet to an iron pin; thence N. 69-46 W., 80 feet to an iron pin on the eastern side of said 5 foot screen; thence along the line of said screen, S. 29-02 W., 180.1 feet to an iron pin on the northern side of Aberdeen Drive, the point of BEGINNING, together with all the right, title and interest of the grantor herein, if any, in and to said 5 foot screen.
