WHEREAS, the Mortgagor is well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty-One Thousand Fifty and 00/100 ----- DOLLARS

(\$ 31,050.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on either or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the southern side of Dellwood Drive, and being known and designated as Lot No. 42, according to a plat of the "Map of Division portion Lots 18 and 19, Essex Court" prepared for Central Development Corporation by Dalton and Neves Engineers, dated July, 1953, and recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book DD at Page 165A and having according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin at the joint front corner of Lots 41 and 42, on the southern side of Dellwood Drive, and thence with the common line of said lots, S. 1-33 E. 174.2 feet to an iron pin on a branch; thence with the branch as the line, S. 89-43 W. 111.3 feet to an iron pin at the corner of property now or formerly owned by Stone; thence with the common line of said property, N. 1-22 W. 165 feet to an iron pin on the southern side of Dellwood Drive; thence with the southern side of Dellwood Drive, N. 83-06 E. 75 feet to the point of beginning.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagor promises to pay to the mortgagee a monthly premium necessary to carry private mortgage guaranty insurance until the principal balance reaches 80% of the original sales price or appraisal, whichever is less.
