(hereinafter referred to as Mortgagor) is evidenced by the Mortgage promissory note of even date herewith, the terms of which are as follows:

Thirty-seven Thousand Nine Hundred and no/100 Dollars (\$37,900.00) principal sum, which principal sum together with interest shall be due and payable in equal monthly installments of \$244.19 each commencing September 25, 1973, and continuing on the first day of each month thereafter with the remaining unpaid balance being due and payable in full on August 25, 2003. Each said installment payment shall be applied first to interest and then to principal. August 1, 1973 at the rate of six percentum per annum, to be paid monthly.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time his advances made to or for his account by the Mortgagor, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagor, the Mortgagor's heirs, successors and assigns:
