DOONIE S. TAYLOR made this 19th day of March, 1978, THIS MORTGAGE between the Mortgagor, William H. Burr and Hazel S. Burr, formerly Hazel Smith Riddle, (herein "Borrower"), and the Mortgagee, GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of SOUTH CAROLINA, whose address is 107 Church Street, Greer, South Carolina 29651 (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of SIXTEEN THOUSAND AND NO/100 (\$16,000.00) Dollars, which indebtedness is evidenced by Borrower's note dated July 28, 1977, (herein "Note"), providing for monthly install- corner of J. B. ALSO: All that certain parcel or lot of land situate, lying and being in of South Carolina, County of Greenville, about two miles south of Greer, near Pleasant Grove Baptist Church, on the southwest side of the junction of Mullinax Drive with Suber Road, being shown as containing 1.07 acres on a plat of property prepared for Hazel Smith Burr by Wolfe and Huskey, Inc., Surveyors, dated December 8, 1975, recorded in Plat Book 5-11, page 149, and having such metes and bounds as is thereby shown.
