ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

Greenville, in Butler Township, on the southern side of S. C.

Highway No. 296, and on the west side of a county road, and having the following metes and bounds, according to a plat made by C. O. Riddle, March 31, 1958, to-wit:
