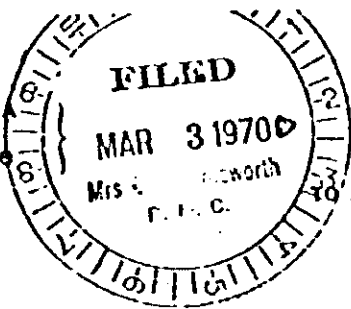

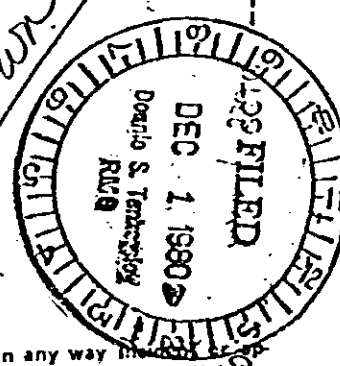
Four thousand two hundred and no/100- - - - - Dollars (\$4,200.00 ) due and payable \$60.00 per month until principal and interest are paid in full-
