THIS MORTGAGE is made this 29 day of October,
1979, between the Mortgagor, Timothy F. Smith and Lavon J. Smith
(herein "Borrower"), and the Mortgagee, First Federal
Savings and Loan Association, a corporation organized and existing under the laws of the United States
of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").
