ALL that certain piece, parcel, or lot of land containing five (5) acres, more or less, situated and being on the South side of the Groce Meadow Road, between Greer and Mountain View School, Oneal Township, County of Greenville, State of South Carolina, and being shown on a plat of the property of Paul F. Barbare by John A. Simmons, R.L.S., dated April 5, 1965, amended March 15, 1971, and having the following courses and distances, to-wit:
