MORTGAGE OF REAL PROPERTY

THIS MORTGAGE made this 12th day of July, 19 78,

ALL that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being in the Town of Mauldin, County of Greenville, State of South Carolina, and being shown and designated as Lot No. 62 on plat of Parkwood Subdivision Sections I and II, prepared by C. O. Riddle, Surveyor, November 5, 1971, and recorded in Plat Book 4-R at Page 42, in the R.C. Office for Greenville County, South Carolina and having, according to a more recent survey of property of Barry L. Rowland and Linda H.
