(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of SIXTY THREE THOUSAND SIX HUNDRED AND NO/100-----

DOLLARS (\$ 63,600.00 ) with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, lying and being on the Southeasterly side of Sugar Creek Road near the City of Greenville, South Carolina, being known and designated as Lot No. 61 on plat entitled "Map No. 5 Sugar Creek" as recorded in the REC Office for Greenville County S.C. in Plat Book 6-H at page 2 and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeasterly side of Sugar Creek Road said pin being the joint front corner of Lots Nos. 60 and 61 and running thence with the common line of said lots S. 57-26 E. 183.95 feet to an iron pin at the joint rear corner of Lot Nos. 60 and 61; thence N. 22-41-05 E. 126.88 feet to an iron pin at the joint rear corner of Lot Nos. 61 and 62; thence with the common line of said lots N. 57-26 W. 161.77 feet to an iron pin on the Southeasterly side of Sugar Creek Road thence with the Southeasterly side of Sugar Creek Road S. 32-34 W. 125 feet to an iron pin the point of BEGINNING.
