(hereinafter referred to as Mortgagor) is well and truly indebted unto

(hereinafter referred to as Mortgagor) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Three thousand four hundred seventy eight and 20/100 Dollars (\$ 3478.20) due and payable by buyer in 60 consecutive monthly installments of \$57.97 each, beginning on the 1st day of June, 1971 and continuing on the same day of each succeeding month thereafter until paid in full.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagor for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or to his account by the Mortgagor, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, and granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagor, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

All that certain piece or lot of land lying and being in Greenville County, South Carolina, known as Lots 5 and 6 of W. E. Reeves property, as shown on a plot thereof prepared by W. J. Riddle in June of 1946, with dimensions as follows: 117' by 158.2' by 114.2' by 141.4' and

more particularly described in the hereinafter mentioned deed.

Being the same real estate conveyed to Mary E. Mosley by deed from Minnie Childress Owens, dated May 20, 1970, recorded June 1, 1970, in the Office of the Clerk of Court for Greenville County, South Carolina, in Deed Book 891, page 64.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
