NOW, KNOW ALL MEN, THAT the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situated, lying and being in the State of South Carolina, County of Greenville, LOVE, THORNTON, ARNOLD & THOMASON S.E.W.

All that piece, parcel or lot of land located in the County of Greenville, State of South Carolina and being shown on a plat entitled "Property of Robert J. Bailey", dated January 13, 1975, and being more particularly described as follows:

Beginning at a point on the eastern side of U. S. Highway 276 at the corner of other property of Robert J. Bailey and running thence S. 87 E. 50 feet to a point in the line of property now or formerly belonging to S. S. P. Enterprises; thence with the line of property now or formerly belonging to S. S. P. Enterprises, N. 12-49 E. 293.3 feet to a point; thence N. 87 W. 50 feet to a point, which point is located in line of property now or formerly belonging to Southern Barbadoes Trust Company, as Trustee and property of Robert J. Bailey; thence with line of property now or formerly of Robert J. Bailey, S. 12-49 E. 293.3 feet to an iron pin on the eastern side of the right of way of U. S. Highway No. 276, the point of beginning.
