NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the above-mentioned debt, and in order to secure the payment thereof, and of any other and further sums he which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or in his account by the Mortgagor, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor as and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, Bargain, sell and release unto the Mortgagor, its successors and assigns:

All that certain piece, parcel, or lot of land in the County of Greenville, State of South Carolina, on the westerly side of Bon Air Street, being shown and designated as part of Tract No. 6 on plat of Property of J. W. Clyde, recorded in the RMC Office for Greenville County, S. C., in Plat Book "DDD", at Page 159, and also being shown on more recent plat of Property of Donelli L. Howell, prepared by R. B. Bruce, RLS, May 19, 1965, and having, according to said more recent plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the westerly side of Bon Air Street, which iron pin is 146.4 feet north of Bon Air Street and Fairfield Drive, and running thence N. 80-31 W. 259 feet; thence N. 9-29 E. 50 feet; thence N. 39-07 W. 84.3 feet; thence N. 87-50 W. 50 feet; thence N. 2-10 E. 100 feet; thence S. 87-49 E. 308.4 feet to an iron pin on the westerly side of Bon Air Street; thence with the westerly side of Bon Air Street S. 8-45 E. 250 feet to the point of BEGINNING.
